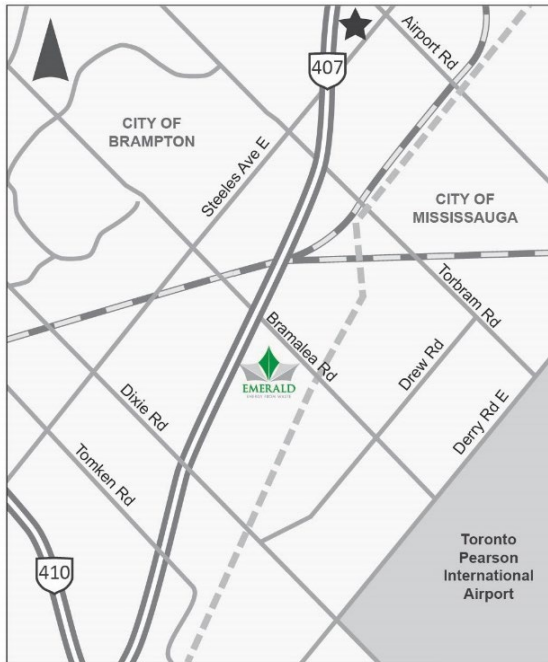

Emerald Energy from Waste Redevelopment Environmental Screening Notice of Completion (Revised)



Emerald Energy from Waste Inc. has completed the environmental screening process for a proposed redevelopment of its energy from waste facility located at 7656 Bramalea Road, in Brampton, Ontario. The proposed redevelopment will increase the annual processing capacity of the facility from 500 tonnes per day to up to 2,500 tonnes per day and the energy recovery from 10 MW to up to 100 MW.

Environmental Screening Process for Waste Management Projects

The environmental screening process was conducted in accordance with Part B of the Guide to Environmental Assessment Requirements for Waste Management Projects dated March 15, 2007 and amended from time to time.

The Screening process involved identifying and applying screening criteria to determine and describe potential environmental effects, public/external agency consultation, and the development of measures to mitigate identified

environmental effects.

The results of the process were documented in an Environmental Screening Report, which has been updated, and which will be available for a 60-day review period starting November 8, 2024, and ending on January 7, 2025. Any comments or concerns regarding the project or the Environmental Screening Process should be addressed to the contact above. Comments or questions submitted to Emerald Energy from Waste Inc. will be reviewed and Emerald Energy from Waste Inc. will attempt to resolve concerns prior to the end of the public review period. In the event any environmental concerns cannot be resolved, the Environmental Screening Process provides for any person to make a written request for elevation to the Minister of the Environment, Conservation and Parks with a copy to the Director of the Environmental Assessment Branch and Emerald Energy from Waste Inc. Requests must be submitted to the Minister within the 60-day review period set out above. Requests submitted after the 60-day review period will not normally be considered.

Information contained in an elevation request will be shared with the proponent, may be circulated to other stakeholders and will form part of the public record. Elevation requests must include the following information:

- The name of the project and name of the proponent;
- The basis of the request;
- That the project be elevated to a comprehensive environmental assessment;
- The nature of the specific environmental concerns that remain unresolved;
- The benefits of requiring the proponent to undertake a comprehensive environmental assessment;
- Information about any efforts to discuss/resolve these concerns/environmental effects with the proponent;
- Details of any correspondence between the person and the proponent; and any other matters considered relevant by the requesting person; and
- Any other information considered relevant.

Elevation requests must be submitted in writing to the Minister and a copy sent to the Director, Environmental Assessment Branch, and Emerald Energy from Waste Inc. at the correct information below:
